PRIVACY POLICY FOR USERS OF THE WEBSITE HTTPS://WWW.MAM2024.COM

Please carefully read this privacy policy (hereinafter, the "Privacy Policy"), which is intended for users (hereinafter, "Users") of the website https://www.mam2024.com (hereinafter, the "Website"), drafted in accordance with Article 13 of the General Data Protection Regulation No. 2016/679 (hereinafter, also "GDPR"), which provides all the details regarding the processing of personal data (hereinafter also, "Data") carried out through the Website.

It is specified that the Privacy Policy is applicable only to the processing of Data carried out through the Website and not to processing carried out on different and additional websites, even if accessible through links within the Site itself.

1. Joint Controllers and related contact information

operate as joint data controllers (hereinafter, "Joint Controllers") of the processing of Data carried out through the Website, as they jointly determine the purposes and means of such processing. In this regard, the Joint Controllers have entered into a specific joint controllership agreement, which defines their respective obligations and responsibilities in the context of the processing of Data carried out through the Website.

2. Contact details of the Data Protection Officers (DPO)

3. Processed Data

The Data collected and processed by the Joint Controllers through the Website are as follows.

3.1 Navigation Data

This category of Data includes IP addresses or domain names of the computers used by Users who connect to the Website, URI (Uniform Resource Identifier) addresses of the requested resources, the time of the request, the method used in submitting the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response from the server (successful, error, etc.), and other parameters related to the operating system and the User's computer environment. This Data is used only for the purpose of collecting statistical information, as well as to monitor the proper functioning of the Website. Furthermore, the Data may be used to ascertain liability in case of hypothetical computer crimes against the Website. Except for this latter possibility, navigation Data is deleted after 7 days.

3.2 Cookies

The Website only hosts session technical cookies (non-persistent), for purposes strictly limited to what is necessary for safe and efficient navigation of the Website.

3.3 Data Voluntarily provided by the User

The Website offers Users the opportunity to voluntarily provide personal information by completing the registration form for the event named "Mediterranean Aerospace Matching" (hereinafter, "Event"), located within the Website itself, on the "Registration" page.

Data processing related to Event registration is described in a dedicated privacy notice, located at the bottom of the information collection form and reachable at the following link (https://www.mam2024.com/home/#form), to which reference is made for all details regarding the processing of the relevant Data.

The "Matchmaking" section of the Website also allows Users to register, by providing their Data, for one-to-one meetings between industry operators (hereinafter, "Meetings") through a dedicated platform (hereinafter, "Matchmaking Platform"), which can be reached at the following link, (https://meetings.mam.bciaerospace.com/2024/signup.php.). Regarding the details about the processing of personal data related to the registration to the Meetings, please refer to specific privacy notice loaded at the link located below the registration form of the Matchmaking Platform.

4. Purposes of Processing

Within the scope of Data processing carried out through the Website, the Joint Controllers pursue the following specific purposes.

4.1 Compliance with legal obligation

The Joint Controllers, where necessary, process the Data to ensure compliance with the legal obligations, regulations, and community rules to which they are subject.

Legal basis for processing: Article 6(1)(c) of the GDPR, "processing is necessary for compliance with a legal obligation to which the controller is subject".

Retention period: the Data are stored for the period strictly necessary to enable the Joint Controllers to fulfill the legal obligations to which they are subject.

4.2 Assertion, exercise, and defense of rights in judicial proceedings

The Joint Controllers, where necessary, process the Data to assert, exercise, or defend their own rights in judicial proceedings or whenever judicial authorities exercise their judicial functions.

Legal basis for processing: Article 6(1)(f) of the GDPR, "processing is necessary for the purposes of the legitimate interests pursued by the controller".

Retention period: the Data are stored for the strictly limited period corresponding to the duration of the legal proceedings, until the expiry of the limitation periods for challenging actions.

5. Recipients of personal Data

The Data collected through the Website may be shared by the Joint Controllers with:

- authorized persons, respectively, by each Joint Controller for the processing of personal data, who have received adequate operational instructions, committed to confidentiality, or are subject to an appropriate legal obligation of confidentiality;
- delegates and/or individuals appointed by the Joint Controllers to carry out activities strictly related to
 the pursuit of the above-mentioned purposes (including technical maintenance interventions on
 systems), duly appointed as data processors;
- individuals, companies, or professional firms providing assistance and consultancy services to the Joint Controllers, duly appointed as data processors;
- subjects, entities, or authorities to whom the communication of Your Data is mandatory pursuant to legal provisions or orders from competent authorities.

The management and storage of Data take place on servers owned by AdP, located within the European Union.

6. User rights

Consistent with the provisions of the GDPR, Users have the right to request from the Joint Controllers, at any time, access to their Data, the rectification or erasure of such Data, as well as the right to object to their processing. The law also allows Users, in cases provided for in Article 18 of the GDPR, to obtain the restriction of processing, and, in cases provided for in Article 20 of the GDPR, to receive the Data concerning them in a structured, commonly used, and machine-readable format.
